# RG/2 ELECTRONIC FILING REQUIREMENTS GRIDSUM SECURITIES SETTLEMENT

- 1. **Signed Master Proof of Claim** and release must be submitted with electronic file covering all the accounts included on the file.
- 2. **Cover Letter** specifying case name, <u>number of accounts</u> and number of lines included on the file, contact name including phone number and e-mail address, wording indicating the company attests to the truth and accuracy of the information on the file, and an authorized signature.
- 3. **Proof of Authority** indicating that the company is authorized to sign on behalf of its clients and that the signor of the claim is authorized to sign on behalf of the company submitting the file.
- 4. **Electronic File** in excel format. This file may be sent on either on a flash drive or sent via e-mail to tchiango@rg2claims.com or info@rg2claims.com.
- 5. There should be 3 tabs on the Excel file as follows:
